# BSC Sport-Specific Rules: Listed by Season (11/10/11 Final)

# **ATHLETIC TRAINERS' GUIDELINES:**

- •A BSC Athletic Trainer's Directory is provided to each member school in order to better facilitate communications relative to areas concerning sports medicine.
- All athletic trainers should regularly communicate with the opposing athletic director and coaches prior to games between the two schools. Specifics should include the following:
  - 1. Any taping of opposing players
  - 2. Any specific medical problems of opposing players (allergies, bee stings, asthma, etc.)
  - 3. Supplying ice and water
  - 4. Relaying information of injured players, especially if player needs /requires hospitalization.
  - 5. Arranging game site coverage.
- •Athletic Directors should keep the trainer directory in order to arrange game coverage if a school does not have a trainer on site.
- •The trainer will provide information if an injured athlete warrants an insurance claim.
- •An athletic trainer MUST be in attendance at all BSC Championship events, multi-school events, BSC meets and BSC Cheerleading and/Dance competitions. Note: Trainers who work All Star events will be paid at the same rate as an assigned game official. Gate receipts may be used to pay for the athletic trainer. If there are no gate receipts, the BSC will pay for the trainer. The host school is not responsible for payment of the trainer.
- Return-to-play, as per MIAA Rule 56: The athletic trainer and the team doctor have the final say/decision re players returning to play after an injury. A coach does not make this decision.
- Rule 56 Point-of-emphasis, as per Massachusetts Senate Bill 2469 (Education concussion law): athletic trainers and coaches must complete concussion education; schools must develop pre-participation forms wherein student-athletes and families may provide head-injury history; any student-athlete suspected of concussion or diagnosed with concussion by a licensed medical professional must be removed from a practice or contest; school and/or medical staff must notify parent(s); any student-athlete suspected of or diagnosed with concussion may not return to participation before providing written authorization from a licensed physician, licensed neuropsychologist, certified athletic trainer or other qualified and licensed medical professional.
- School-to-school communication will occur to support Rule 56 notification policies. E.g. host school AD and/or LATC will communicate to visiting school AD and/or LATC regarding diagnosed or suspected head injury to visiting school student-athlete.

# FIELD HOCKEY

- 1. All contests will be played using **NFHS** rules with MIAA and BSC modifications.
- 2. All M.I.A.A. rules and modifications will be adhered to at all levels for all sports.
- 3. Starting times will be 3:45 pm unless otherwise noted.
  - No games may start prior to 3:30 pm unless mutually agreed upon (Fall daylight savings time 3:15 pm will be the league standard at the appropriate date)
- 4. Board certified officials will be used in all contests whenever possible.
  - Guidelines for reassignment of officials, in cases of shortage, are as follows:
- In all sports at the varsity level (unless specific sport rules dictate otherwise) if at least half the number of certified assigned officials are present, the game will be played. At the sub varsity level, if no officials are present, the game will be played under the supervision of both coaching staffs. Sub varsity officials may be reassigned to work the varsity game. However, every effort should be made to leave the sub varsity official at their assigned game.
  - #officials assigned to each sport and sport level: Varsity: 2 (except football = 5); Sub-Varsity: 2 (recommended)
- 5. Adult Timekeepers should be used whenever possible. Home scorebook is the official scorebook.
- 6. Postponement policies: see Article #10 Sections G and H.
- 7. Pre and Postseason meetings will be held in all sports. A coach or designee must be in attendance at these meetings
- 8. A media rep should be selected for each sport and he/she is responsible for compiling league standings in that sport and reporting to all media outlets. Coaches of contests are responsible for calling scores into the media. All coaches must update records and standings with BSC media rep.
- 9. Official ball for this sport is: either the Chingford or leather ball will be accepted.
- 10. Uniforms and equipment: all home teams will wear white.

- 11. The early dismissal of teams for BSC competition is at the discretion of each school to decide.
- 12. A player may compete in only one varsity sport during any one MIAA season.
- 13. No member of an athletic staff will engage in scouting of an opponent's practice session. Pre season scrimmages may be scouted by consent of participating schools.
- 14. Ticket prices are home rule with BSC recommendations.
- 15. Coach and Student suspension forms: It is recommended that all coaches carry MIAA games suspensions forms. The home team is responsible for completion of the form by the game official and must present the completed form to the home athletic director within twenty four hours
- 17. All athletic teams must be accompanied by an adult school representative (employed by the school) and that person must remain with the team throughout the competition.
- 18. Authorized video-taping is allowed by all BSC schools in all sports unless specific sport rules dictate otherwise.
- 19. If an official arrives at the contest site, without prior notification, and the contest is subsequently postponed or suspended, the official will receive one-half fee.

### .Scheduling guidelines: In addition to below see Article #10:

- •Varsity /JUNIOR VARSITY Field Hockey: Each school will play divisional schools twice and non-divisional schools once. The 8<sup>th</sup> and 16<sup>th</sup> games on the schedule are played against divisional opponents (traditional rivals), when possible, and are locked on the schedule. The schedule changes sites annually and rotates from top to bottom every other year. Attempts are made to avoid 3 game weeks (or to keep them to a minimum). The schedule consists of 10 divisional dates and 6 non divisional dates. Most teams will piggy-back the varsity and JUNIOR VARSITY games with the varsity playing first, followed by the JUNIOR VARSITY game.
- •Freshman Field hockey: same scheduling order, dates and times, as varsity, but opposite sites.

# Field Hockey: Specific rules: BSC revisions 4/3/06

- 1. The entire varsity game is to be played first, then the entire junior varsity game.
- 2. Time of halves Weather permitting: Varsity 30 minutes; JUNIOR VARSITY 25 minutes.
- 3. The Conference provides field hockey officials for all games.
- 4. The home team will be the official scorer and official timer.
- 5. A tie game shall stand. No overtime.
- 6. Substitution: any player may leave a game and return any number of times on that team's free hit or corner, except during the first five minutes of a varsity game.
- 7. No one may play more than two halves of the varsity and junior varsity contests combined.
- 8. All coaches are reminded to instill characteristics of good sportsmanship in their players and that proper language is to be used at all times

### **GIRLS SWIMMING RULES**

- 1. All contests will be played using **NFHS** rules with MIAA and BSC modifications.
- 2. All M.I.A.A. rules and modifications will be adhered to at all levels for all sports.
- 3. Starting times will be 3:45 pm unless otherwise noted.
  - No games may start prior to 3:30 pm unless mutually agreed upon (Fall daylight savings time 3:15 pm will be the league standard at the appropriate date)
- 4. Board certified officials will be used in all contests whenever possible.
  - Guidelines for reassignment of officials, in cases of shortage, are as follows:
- In all sports at the varsity level (unless specific sport rules dictate otherwise) if at least half the number of certified assigned officials are present, the game will be played. At the sub varsity level, if no officials are present, the game will be played under the supervision of both coaching staffs. Sub varsity officials can be reassigned to work the varsity game. However, every effort should be made to leave the sub varsity official at their assigned game.
  - #officials assigned to each sport and sport level: Varsity: 2 (except football = 5); Sub-Varsity: 2 (recommended)
- 5. Adult Timekeepers should be used whenever possible. Home scorebook is the official scorebook.
- 6. Postponement policies: see Article #10 Sections G and H.
- 7. Pre and Postseason meetings will be held in all sports. A coach or designee must be in attendance at these meetings

- 8. A media rep should be selected for each sport and he/she is responsible for compiling league standings in that sport and reporting to all media outlets. Coaches of contests are responsible for calling scores into the media. All coaches must update records and standings with BSC media rep.
- 9. The early dismissal of teams for BSC competition is at the discretion of each school to decide.
- 10. A player may compete in only one varsity sport during any one MIAA season.
- 11. No member of an athletic staff will engage in scouting of an opponent's practice session. Pre season scrimmages may be scouted by consent of participating schools.
- 12. Ticket prices are home rule with BSC recommendations.
- 13. Coach and Student suspension forms: It is recommended that all coaches carry MIAA games suspensions forms. The home team is responsible for completion of the form by the game official and must present the completed form to the home athletic director within twenty-four hours
- 14. All athletic teams must be accompanied by an adult school representative (employed by the school) and that person must remain with the team throughout the competition.
- 15. Authorized video-taping is allowed by all BSC schools in all sports unless specific sport rules dictate otherwise.
- 16. If an official arrives at the contest site, without prior notification, and the contest is subsequently postponed or suspended, the official will receive one-half fee.

### Scheduling guidelines: In addition to below see Article #10:

Each school that sponsors swimming will compete against other BSC schools once in a season. BSC meets are usually scheduled on Tuesdays and Fridays. Meet times vary widely due to use of private pools. Every attempt is made to avoid conflicts between schools that use the same facility. The schedule is adjusted so that 2 teams, that use the same facility for home meets, do not have home meets scheduled on the same date. This causes some variance in schedules on an annual basis.

### Girls Swimming Sport Specific Rules (4/3/06)

- 1. If a team does not have divers, the team forfeits the points to the team which does have divers. Points are based on the actual number of divers.
- 2. Bona fide Team Member Rule must be reviewed and understood by all coaches and athletes.
- 3. All schools shall submit liability binder insurance to each pool in the league.
- 4. The Conference Meet will be held each season prior to the cut-off date.

## FOOTBALL RULES

- 1. All contests will be played using NCAA rules with MIAA and BSC modifications.
- 2. All M.I.A.A. rules and modifications will be adhered to at all levels for all sports.
- 3. Starting times will be 3:45 pm unless otherwise noted.
  - No games may start prior to 3:30 pm unless mutually agreed upon (Fall daylight savings time 3:15 pm will be the league standard at the appropriate date)
- 4. Board certified officials will be used in all contests whenever possible.
  - Guidelines for reassignment of officials, in cases of shortage, are as follows:
- In all sports at the varsity level (unless specific sport rules dictate otherwise) if at least half the number of certified assigned officials are present, the game will be played. At the sub varsity level, if no officials are present, the game will be played under the supervision of both coaching staffs. Sub varsity officials can be reassigned to work the varsity game. However, every effort should be made to leave the sub varsity official at their assigned game.
- #officials assigned to each sport and sport level: Varsity: 2 (except football = 5+ time keeper); Junior Varsity: 3 (recommended); Freshman: 3 (recommended)
- 5. Adult Timekeepers should be used whenever possible. Home scorebook is the official scorebook.
- 6. Postponement policies: see Article #10 Sections G and H.
- 7. Pre and Postseason meetings will be held in all sports. A coach or designee must be in attendance at these meetings
- 8. A media rep should be selected for each sport and he/she is responsible for compiling league standings in that sport and reporting to all media outlets. Coaches of contests are responsible for calling scores into the media. All coaches must update records and standings with BSC media rep.
- 9. Official ball for this sport is: MIAA standard or equivalent.
- 10. Uniforms and equipment: all home teams will wear dark.

- 11. The early dismissal of teams for BSC competition is at the discretion of each school to decide.
- 12. A player may compete in only one varsity sport during any one MIAA season.
- 13. No member of an athletic staff will engage in scouting of an opponent's practice session. Pre season scrimmages may be scouted by consent of participating schools.
- 14. Ticket prices are home rule with BSC recommendations.
- 15. Coach and Student suspension forms: It is recommended that all coaches carry MIAA games suspensions forms. The home team is responsible for completion of the form by the game official and must present the completed form to the home athletic director within twenty four hours
- 17. All athletic teams must be accompanied by an adult school representative (employed by the school) and that person must remain with the team throughout the competition.
- 18. Authorized video-taping is allowed by all BSC schools in all sports unless specific sport rules dictate otherwise.
- 19. If an official arrives at the contest site, without prior notification, and the contest is subsequently postponed or suspended, the official will receive one-half fee.

### Scheduling guidelines: In addition to below see Article #10:

- •Each school will play all 11 other BSC schools. The BSC schedules games for 1:00 PM on Saturday or 10:00 AM on Thanksgiving. By mutual consent of both schools a game may be moved to 7:00pm on a Friday or Saturday, or 10:00AM on a Saturday. Other day or date or time changes may be necessary, and are allowed, due to holidays, field problems, SATs, PSATs, holidays, or DST.
- •The schedule consists of five (5) non divisional dates, four (4) divisional dates, and two (2) inter divisional dates. The interdivisional dates (10 and 11) are necessary because of traditional Thanksgiving rivalries. The other dates rotate every other year from top to bottom with the restriction that a non divisional date must be scheduled first. This is in the event the MIAA restricts the season to ten (10) games. If this happens the first date will be dropped from the schedule.
- •Junior Varsity football: follows the same schedule as the Varsity. Game time is generally Mondays at 3:45 pm (3:15pm DST). Sometimes Home Rule may impact date/day/time.
- •Freshman football: Follows same schedule as varsity but at opposite site. Game day/time is generally Friday at 3:45pm (3:15pm DST). Home Rule may impact date/day/time. The BSC has agreed not to play a freshman game against the first opponent on the schedule. By mutual consent this game may be played as a controlled scrimmage.

### **Football Specific Rules:**

- 1. **Varsity periods** shall be 12 minutes in length.
- 2. When **cancellation of a game** is necessary because of conditions beyond our control, the visiting team will be notified at least 2 hours before game time.
- 3. There shall be **5 officials** appointed by the commissioner for each game.
- 4. A League football game that is called off on:
  - A. **Friday** must be rescheduled for the following Saturday.
  - B. Saturday must be rescheduled for the following Sunday.
  - C. **Sunday** must be rescheduled for the following Monday.
  - D. **Monday** mutual consent of the Athletic Directors.
- 5. A League **JUNIOR VARSITY game** that is called off on **Monday** because of unplayable conditions or the rescheduling of a varsity game, may be played on Tuesday. If the game must be called off on Tuesday, it shall be cancelled.
- 6. Exchange of game tapes:
  - A. There is an open video exchange in the League. Videos of the last two games will be sent by noon the day after the most recent game.
- 7. Only Captains are to be at midfield at the coin toss. Everyone else will be on the sidelines.
- 8. **Inclement Weather Rule:**

The **HOME TEAM** may rule that its field is unplayable; and therefore, eliminate the need for the visiting team to travel. If the home team feels that the field is playable and asks the visiting team to travel, the visiting team is obligated to do this unless at least two other Bay State Conference games have already been called off. If two or more games have already been called off, the visiting team may refuse to play and the game must be rescheduled. Once the two teams arrive at the field, the two Athletic Directors shall check the field and decide on a course of action. If one team wants to play and the other does not, the matter of two or more other postponements may be involved (as above). If there is not two other postponements, and one team refuses to play, the other team may ask the Conference to award a forfeit.

- 9. **Football rosters** should be ready 8 days prior to the first game. Rosters should include names, numbers, positions and class.
- 10. Procedure for bands to follow at football contests:

GAME TIME: 1:00pm

VISITING BAND: 12:45pm (one song only-either march/song) HOME BAND: 12:45pm (one song only - either march/song)

National Anthem played at 12:57pm with combined bands and played in B Flat Concert. While bands are combining to play National Anthem, officials will have captains out for coin toss. After officials show who receives and who kicks, the public announcer, upon signal of the visiting band director, will announce the playing of the National Anthem.

HALFTIME: (20 minutes) Visiting Band: 8 minutes Home Band: 8 minutes

The HOME Athletic Director will have areas reserved and protected for both bands before and after the first half.

12. **It has been voted that one participant may play in only one JUNIOR VARSITY or freshmen game during any week.** It was recommended that game participation be limited to not more than the equivalent of one full game each week.

**EXCEPTION:** Rather than cancel a sub varsity game, a school may use other sub varsity players within reason.

- 13. All-Star Selection: Amended 8/26/09--(\*\*see Article 11 Section C)
- 14. A **tie breaker** will be played in all BSC varsity football games, consistent with NCAA rules and BSC modifications: alternating possessions from the ten yard line and teams must go for two-point conversion after 1<sup>st</sup> possession.
- 15. **No still pictures or video-taping** may be taken for scouting purposes, except as allowed by league-authorized tape exchange.
- In games suspended at the discretion of the officials because of light failure or any other uncontrolled reason, the team that is behind will have the option to call the game "over" or pick it up at that point on the next available date.
- 17. Bay State Conference Tie Breaker Used For Determining Playoff Representatives:

NOTE: This proposal will work only if the MIAA allows the Conference to play all games to completion, no ties. The recommendation to the MIAA is to allow more than one tie breaker, conducted under the present rules with one exception. If a game remains tied after one session of overtime, all remaining overtime sessions to be played with the amendment: "both teams <u>must</u> attempt a 2 point conversion from scrimmage after scoring a touchdown." The tie breaking system that follows is to break ties based on what happened on the field, as much as is possible, and not to: (1) eliminate a school because they played most recently in the playoffs (penalizes good programs) or (2) to determine, as infrequently as possible, a playoff bid by a coin toss.

A: First and foremost tie breaker for playoff bid is always head-to-head competition between 2 teams. (Note) With no tie games possible, under the above proposal to the MIAA, playoff bid ties, within the same Division, would have to be between more than 2 teams.

B: If tie for bid occurs in a Division, then one team could be eliminated by examining the game results against the other Division's champion. Once that one team is eliminated, we go back to head to head.

Example: In Herget Division 3 teams: A, B and C are tied with a record of 9-2. (Within the Division A beat B, B beat C and C beat A. All three schools lost a game to a Carey Division school.) Team X won the Carey division. In non-divisional play:

A beat X, B beat X, C lost to X. C is eliminated.

Tie now exists between A and B but, A beat B therefore B is eliminated.

Team A gets the playoff bid because head to head competition breaker is applied.

C: Three way tie is not broken after applying Rule 2. Next step is to examine point differential, in first half only, against other divisional champion. (First half score only to prevent "run ups" in any League contest. This tie-breaker is based on te premise that the first half of any game is played by the first units of both teams. It is an unwritten rule that teams really can't be accused of running the score in the first half. After examining this, the team with the lowest positive point differential or highest negative point differential is eliminated. The remaining two way tie is broken by head to head.

Example 1: Three teams in Herget Division: A, B, and C end the season with records of 10-1 and all three won their contest over team X, the Carey Division Champion.

A beat B, B beat C, and C beat A.

In games against X the scores, at the end of the first half were:

A-18, X-21: -3 differential B-10, X-7: +3 differential

C-14. X-8: + 6 differential

Team A eliminated, lowest differential...Playoff team determined by head to head between B and C...B gets bid.

Example 2: Same three way tie as in example one:

In games against X the scores at halftime were:

A-18, X-21: -3 differential B -7, X-10: -3 differential

C-10, X-14: -4 differential

C eliminated. A gets bid because of head to head against B.

Example 3: Same three way tie as in example one:

In games against X the scores at halftime were:

A-18, X-21: -3 differential B-7, X-10: -3 differential C-14, X-14: 0 differential

A and B are now tied, with C waiting (because their differential is higher).

B eliminated because A beat them. C gets bid because they beat A head to head.

Example 4: Same three way tie as in example one:

In games against X the scores against X were:

A-18, X-15: +3 differential B-10, X-8: +2 differential C-10, X-7: +3 differential

B eliminated, lower differential. C gets bid from head to head against A.

(There may be other possible cases in 3<sup>rd</sup> level tie breaker)

D. If still tied repeat steps 2 and 3 vs. the second place team in the other division. If a tie still exists, continue using subsequent teams from other division in order of finish in standings until tie is broken.

Division (co or tri) still determined by record only, as we do now.

The schedule changes sites annually and rotates from top to bottom every other year. Attempts are made to avoid 3 game weeks (or to keep them to a minimum). The schedule consists of 10 divisional dates and 6 non divisional dates. The BSC plays boys' varsity and junior varsity soccer at one site and girls' varsity and junior varsity soccer at the opposite site on every scheduled date.
- Freshman B/G Soccer: schedule these games on dates when the varsity and junior varsity are not scheduled to play. Every attempt is made to follow same schedule as varsity and junior varsity boys and girls soccer respectively.

### BSC B/G Soccer Specific Rules: REVISIONS 2005-2006

- 1. There shall be at least two board officials assigned to all Varsity games.
- 2. Official time will be kept by the officials on the field.
- 3. The BSC Champions (divisional) will be determined by the best Won-Lost Record, using 2 points for a win, 1 point for a tie, and 0 points for a loss.
- 4. Junior Varsity games will be played with a minimum of seven players and teams will play at equal strength (7v7).
- 5. Varsity and JUNIOR VARSITY games will be 40 minute halves with NO overtime.

  - No games may start prior to 3:30 pm unless mutually agreed upon (Fall daylight savings time 3:15 pm will be the league standard at the appropriate date)
- 4. Board certified officials should be used in all contests whenever possible.
- 5. Adult Timekeepers should be used whenever possible. Home scorebook is the official scorebook.
- 6. Postponement policies: see Article #10 Sections G and H.
- 7. Pre and Postseason meetings will be held in all sports. A coach or designee must be in attendance at these meetings

- 4. League Representative to News Media. Call or email every week before noon on Sunday with all results.

### **Scheduling:**

Once-around schedule begins fall '10. Use the same order as football. Schedule is much more compressed due to early MIAA cut-off date. Three matches per week is commonplace. Home course restrictions will drive the schedule.

### **Golf Specific rules:**

- 1. All matches will be played using the United States Golf Association Rules.
- 2. Matches will start at 3:30 PM, but may vary due to country club regulations.

Low ball shall count only on each hole for both twosomes and foursomes. Match tiebreaker is low-medalist for the round, and second medalist, if still tied. If match is still tied then final result is a tie. Play out all holes.

### **Dual Meet Competition Format:**

#### 1. Order of Events:

- Uneven Bars
- Balance Beam
- Vaulting
- Floor Exercise

**NOTE** - The preference in the Bay State conference is for split judging. In this case, uneven bars and vault will take place simultaneously, with one gymnast waiting for the other team to dismount. The order of the final events will be balance beam and then floor exercise. For these events, judges will remain together and the teams will alternate competitors.

If split judging is not desired by one or both of the coaches, or if there is only one judge, the order of events will be Uneven Bars, Balance Beam, Vault, and Floor Exercise.

The choice to split judging is made by the coaches.

- 2. Entries: Six participants may be entered in each event. Two participants may compete in the all around.
- 3. **Scoring**: The top four scores in each event count towards the team total.
- 4. **Scoring Set-Up and Procedures:** It is the responsibility of the home school to provide a 'score table' for meet scoring. The 'head table' should accommodate the master scorer for the home and visiting team. The officials should write their scores on a 'score slip' and send the score to the head table via a meet runner. The practice of following a team with a score sheet and recording scores from the flashed score is not appropriate. Please ensure accurate scoring by adhering to proper meet procedures.
- 5. **Home team expectations:** The home team shall provide the following equipment and personnel:
  - 2 chairs for judges
  - 1 runner for scores
  - 1 score indicator
  - Proper safety mats and landing mats 4 inch mats are recommended

Note - Each team will provide their own score sheet and score keeper

#### 6. Judges:

To be assigned by commissioner; two per meet if available: one is allowable. Make sure judges sign all score sheets. Coaches are encouraged to double check proper starting times.

#### 7. Other Recommendations:

- Teams should arrive **one** hour before competition for proper warm up. The recommended warm-up time is 1 hour. In case of delay, the minimum warm-up time should be 30 minutes prior to the start of the meet. The warm-up time and order can also be altered according to coaches' agreement.
- A two-minute touch will be allowed on the floor exercise immediately preceding competition on that event.
- Each coach is responsible for calling in results for the meet to Boston Globe and Boston Herald as well as league coordinator before Sunday.

    - iii. Javelins must have stamp/label identifying compliance with 1999 rule specifications.
    - iv. Maximum 1/4" spikes on all tracks and runways.
    - v. Teams should bring 2 tape measures and 3 starting blocks to away meets. Also check with opposing coach regarding extra hurdles, bars, etc.
    - vi. Pole vault teams competing in the PV must declare at the pre-season meeting and must have certified coaches, athletes (weight) officials, mats and equipment.
    - vii. Uniforms must be school issued, with school name/insignia/colors.
  - b. Participation and time limits for individual athletes
    - i. Dual meets (events): Maximum of 2 Running (including relays) and 2 Field events.
    - ii. Conference League Meet (events): <u>State Meet Rules</u>—(adopted 2011) Any 2 Running and 1 FE or 1 Running and 2 FE. Relays are running events.
    - iii. Dual and League Meet (distance): No 2 events greater than 400m.

- 4. Coaches must report scores to Boston and local papers, immediately. Also, coaches must report scores, standings and outstanding performances to Conference media reps (one boys coach, one girls coach, chosen at pre-season meeting) weekly, during the season.
